According to Article VI (Section 6A) of the Party Bylaws, The Party Chairperson appoints all Convention Committee chairpersons and members. By applying for membership to a convention committee you will be required to sign a participation agreement. Committee meetings will be done via Zoom. If selected by the Party Chairperson, you will receive a notice of appointment no later than 5 days before the first meeting of the committee you were appointed to.

\_\_\_\_\_ **Platform** - To receive proposals to amend or revise the Platform. Prepares a report of recommendations to the Convention.

\_\_\_\_\_ **Rules** - To receive proposals to amend or revise the Constitution and the By-laws of the Party. Shall have the power to format, edit, combine proposed rules changes, and make substantive amendments that do not alter the intent of the proposed rule addition or change. Prepares a report of recommendations to the Convention.

\_\_\_\_\_ **Resolutions** - To receive resolutions. Shall have the power to format, edit, combine resolutions of similar substance, and make substantive amendments that do not alter the intent of the resolving clauses. Prepares a report of recommendations to the Convention.

\_\_\_\_\_ **Affirmative Action** - To receive recommendations concerning Affirmative Actions & to finalize.

\_\_\_\_\_ **Credentials** - To investigate and certify a temporary roll of delegates. The temporary roll as prepared by the Secretary of the State Central Committee will be accepted as prima-facie correct pending action by the duly appointed State Convention Credentials Committee.

(a) The Credentials Committee shall hold hearings to decide a contest with due notice to the parties.

(b) The Credentials Committee shall, throughout the delegate registration period assess a member or members to the Registration Committee to verify & certify a delegate's or an alternate's status for seating as a delegate.
